

INJURIES:

The victim, Joel Kinnamon, stated he was experiencing pain in his chest and back areas. He declined medical attention and stated he would possibly visit a medical facility the following day to be evaluated. I did not observe any injuries on Joel's person. However, in the area of his lower left back, there was possibly bruising.

DETAILS:

On Saturday, January 27, 2024, approximately 1545 hours, while working uniformed patrol for the City of Palm Desert, County of Riverside, I was dispatched to 73300 Fred Waring Drive (Palm Desert Library) Palm Desert, Ca., in regards to an alleged recent battery. Upon arrival, I spoke with the victim, Joel Kinnamon. Joel related the following:

Along with numerous other patrons and political influencers, he was attending a Democratic Party "meet and greet" of sorts. Guest speakers had been scheduled to speak to the audience about issues pertaining to the upcoming election and its respective candidates. One of these speakers was President of the United Food and Commercial Workers Union (UFCW).

After Leach's speech had concluded, the attendees of the event were socializing and discussing the issues brought forth during the event. Per Joel, Leach had not taken kindly to a question he had asked. Leach's displeasure had carried over to this socializing time.
