I'm writing to apply for the Desert Healthcare District & Foundation Board of Directors vacancy as a Zone 5 resident. I bring a track record in public facing governance, legal and policy work, and direct systems experience across homelessness, housing stabilization, reentry, and behavioral health services.

In my current role as Staff Attorney at Starting Over, Inc., I work with community stakeholders to drive policy reforms and expand access to legal services, while providing direct legal assistance across civil rights, housing, and employment matters. Starting Over's mission focus on homelessness, recidivism reduction, and reentry services has sharpened my practical understanding of what it takes to move from crisis to stability. My earlier work includes leadership within the Coachella Valley Association of Governments Homelessness Department, where I led staff and ensured compliance while coordinating with member agencies and the public, and housing program management at the Coachella Valley Rescue Mission, including supervising staff and implementing case management plans for households seeking stable housing.

I understand this is a public fiduciary role requiring disciplined governance: setting policy, approving budgets, managing risk, ensuring legal compliance, and hiring and evaluating the Chief Executive Officer while exercising independent judgment free of conflicts of interest. I'm prepared to serve at that level and to contribute fully to the District's strategic planning process, including special Board workshops and community listening sessions.

My background and experience can contribute to the District's work on behavioral health and substance use continuum, housing as health and homelessness prevention, reentry supports for justice-impacted residents, and early intervention for youth. I bring practical insight into service delivery and case management that can strengthen grantmaking strategy and outcome focused oversight, along with experience coordinating across providers, cities, and agencies in regional homelessness systems. I also bring a policy and access lens informed by legal practice and community trainings aimed at reducing barriers for underserved residents.
